## **Commitment to achieving Net Zero**

Concero UK Ltd is committed to achieving Net Zero emissions by 2040.

### **Baseline Emissions Footprint**

## **Current Emissions Reporting**

Reporting Year: 01/04/2023 – 31/03/2024 (Financial Year)

Emissions for the current year have been projected in line with our reduction targets.

Scope 2	2.0 tCO2e
Scope 3 (included sources)	416.8 tCO2e
Total	421.8 tCO2e

This represents a 12% reduction compared to the baseline year (2022–23).

# **Emissions Reduction Targets**

We remain committed to our trajectory to achieve Net Zero by 2040.

- By 2027, we project carbon emissions will decrease to 191.7 tCO2e, representing a 60% reduction from baseline.

Progress to date shows we are on track, with an estimated reduction from 479.3 tCO2e (2022–23) to 421.8 tCO2e (2023–24).

#### **Carbon Reduction Projects**

Measures implemented or in progress include:

- Introduction of LED lighting across our facilities.
- Launch of a salary sacrifice scheme for electric vehicles.
- Adoption of a cycle-to-work scheme to promote low-carbon commuting.
- Replacement of inefficient appliances with energy-efficient models.
- Increased use of remote collaboration tools to reduce travel emissions.

Future projects under consideration:

- Replacement of gas heating with high-efficiency heat pumps.
- Engagement with suppliers to reduce upstream Scope 3 emissions.
- Procurement of renewable energy for office sites.
- Continued investment in sustainable transport solutions.
